2. **Catering.** You must choose between one of our seven professional accredited outside caterers. The caterers provide linen, crockery, cutlery, kitchen equipment as well a catering manager and staffing for the occasion.

1. On booking the client shall pay to Peacock Events a non-refundable booking fee of £900.00. (including VAT). The booking fee is to be paid and returned together with a signed copy of the contract. A further non - refundable down payment of 50 % of the total hire fee, less the booking fee, is a year ahead of the date of the wedding. The balance of the total price payable shall be paid no less than 6 weeks prior to the event date. For Weddings booked inside a year, a second non refundable downpayment of 50% of the total hire fee is due one calendar month after the booking deposit is paid. The balance of the total price payable shall be paid no less than 6 weeks prior to the event date.
2. Until we receive the deposit your booking is deemed as provisional and we reserve the right to sell the date to others.
3. We will issue you with a detailed payment schedule 3 months prior to the event date and after we have discussed and quoted for your requirements in full. You will be expected to adhere to the schedule of payments, if you fail to do so we reserve the right to cancel your wedding. All down payments are non - refundable.
4. In the unlikely event of a cancellation, we regret that all deposits and instalments are non refundable. We strongly recommend the purchase of specialist wedding Cancellation Insurance.
5. The final details for all events must be agreed at least one month before the function date. Changes to any arrangements made with Peacock Events must be submitted in writing at the earliest possible date and agreed with them.

13. *All alcohol consumed on the premises must be bought through the bar. Complimentary drinks provided by the venue are based on a maximum wedding party of 120 guests. The bar calls last orders at 10.50pm. Live and amplified music finishes at 11pm. The hire of the barn is until 12 mid night.*
14. *No fireworks, chinese lanterns, candles or helium balloons are allowed at Preston Court. 100% real petal Biodegradable confetti only may be used.*
15. *Client must choose between one of our seven nominated caterers to supply their wedding breakfast and all other food consumed at Preston Court.*
